The state of Colorado considers us a non-profit but the Federal tax laws have different categories of charities or on-profits, and PayPal doesn't give every category a break. Randy is working to determine how to establish PPCC as a 501(c)(7) Social Club since we don't qualify as a 501(c)(3) Charity. There are also some potential sales tax collection and payment issues to track. There was a strong suggestion among the group that we should pursue getting the most appropriate status officially, and it will probably be necessary to make changes in the wording of our bylaws. Randy is working on this in a high level of detail so keep an eye out for more info. I'm also going to ask Randy to review and correct this paragraph in case I messed it up...

Sneaking quietly into some personal stuff, as you all know we had another blast of cold weather. The test of the Optima AGM battery lifespan in my red car continues. It has started fine without a battery maintainer. I'm hoping as we work through February and into March, we are not going to see any

more weather that cold. I have on my list to rework the engine bay wiring in the red car to clean that mess up after messing with it at the last Tri-State due to my distributor issue. I think I've figured out that a wire was loose or shorted which is what killed my fuel pump. I'm also continuing to work on moving parts for the blue project car out of my garage and into my daughter's garage in storage after parts have been cleaned and refurbished. I'm very close to being able to get access to the engine area from all directions underneath so I can remove the engine and fiddle with cleaning up the rear suspension.

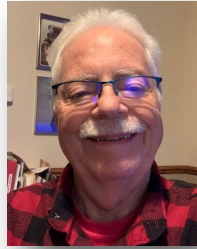
As always, I hope all of you are doing well and are healthy. Take it easy, stay cheerful, stay warm and drive carefully.

Well, it hardly seems possible that this year’s almost a quarter of the way over already at the end of March, but here we are.

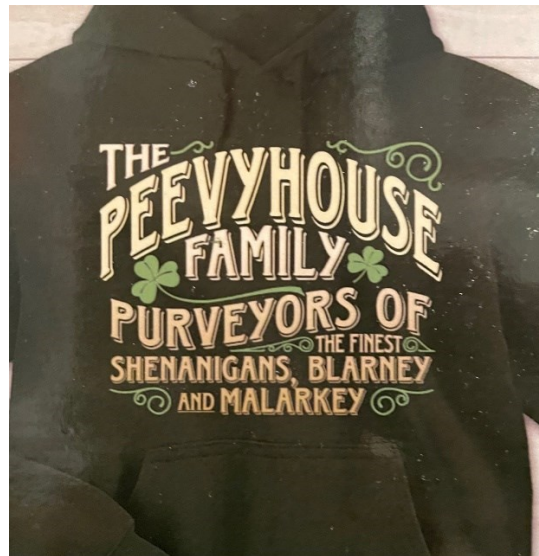


March is sort of a transitional month, weather wise, and also the month for basketball fans to start the countdown to the basketball playoffs called March Madness.

MEETING MINUTES- FEBRUARY 19, 2023

Meeting called to order at 9:38. There were 11 members on site with no visitors. Garrie Fox and Tony and Diane Lawler joined via Zoom.

We were pleased to welcome Chris back after her surgery.

Minutes

January meeting minutes were discussed, approved and seconded. Motion to approve by Jerry, second by multiple members.

Treasury Report

General Fund: \$4890 including Wells Fargo and PayPal. \$1355 in PayPal.

SeeMore Fund: \$2576

Total: \$971.86

Tax exempt status update: We would fall under IRS 501C7 (Social Clubs). Corsa and CNM are 501C7. CPF is a 501C3. Randy did this research regarding reduced fees from PayPal. However, PayPal doesn't recognize 501C7. In addition, this designation doesn't allow tax deductions for donations, and we would need to file taxes. We would also need to change our By-Laws should we have this designation regarding dissolution of the club should we ever dissolve PPCC.

If we were to go down the 501C7 status, we would need to update the By-Laws regarding a 'for profit' organization. Randy will write this information up with additional clarification for The Drip Line.

While getting setup as a 501C7, this would not gain us a lot, it would help to normalize the structure of the organization and have us set up more like other Social Clubs. We are currently recognized by the state as a non-profit, but with no status. The question is whether we wish to update the by-laws and obtain the 501C7 status.

There was a question regarding whether we would have to pay taxes on items such as tee-shirt sales, etc. Randy has not dived into this yet. Rick shared some additional information on this, but without further research we don't have a clear answer. It was suggested that it would be easier to avoid the complications of sales taxes.

KeithAnn made a motion to pursue updating the By-Laws and there were multiple seconds. We will get this information into The Drip Line for the next few months so

that we have time for members to review the changes for a future vote.

Web Site Update

Randy was able to access the old PPCC website and he downloaded all the content (the page is completely intact). There was a suggestion regarding whether they should be put on the new website. Further discussion will be had.

PPCC By-Law Changes for Non-Profit Status

I have learned several things in my attempt to get reduced fees through PayPal.

PayPal allows for reduced fees for charities such as those that qualify for section 501(c)(3) under the IRS code. However, PPCC would not qualify as a charitable organization but may meet the requirements as a 501(c)(7) Social Club. For example, CORSA and CNM are both 501(c)(7) Social Clubs. Corvair Preservation Foundation is a 501(c)(3) Charity. PayPal does not offer reduced fees for 501(c)(7) Social Clubs and since 501(c)(7) are not charitable organizations, donors may not receive a tax deduction when they contribute funds.

So, you ask, why would PPCC pursue registering as a 501(c)(7) Social Club? Since PPCC is in good standing with the state of Colorado as Non-Profit/Tax Exempt and has been since 1982 it would seem appropriate that we also acquire non-profit/tax exempt status at the federal level. There are several requirements to qualify of which PPCC is already meeting. However, the following changes to our By-Laws are proposed:

ARTICLE II – PURPOSE

CHANGE FROM:

“The purpose of the PPCC is to promote the acquisition, preservation, restoration, exhibition, and enjoyment of Corvairs; encourage the preservation and distribution of technical information pertaining thereto; promote sociability among members of the organization.”

CHANGE TO:

“The purpose of the PPCC is to promote the education, preservation, restoration, exhibition, and enjoyment of Corvairs; encourage the preservation and distribution of technical information pertaining thereto; promote sociability among members of the organization. The Club shall not be conducted or operated for profit, and no part of any profits or remainder or residue from dues or donations to the Club shall inure to the benefit of any member or individual.”

ARTICLE VIII

CHANGE FROM:

“SECTION 1. Dissolution: If for any reason this Corporation is disbanded or dissolved, any property held in the corporate name shall be liquidated and turned into cash in accordance with the decision made by the then members. After all Corporation liabilities have been paid, the remaining cash shall be divided among the paid members. Dissolution of the Corporation shall be made in accordance with all applicable Federal and State of Colorado laws.”

CHANGE TO:

“SECTION 1. Dissolution: *The Club may be dissolved at any time by the written consent of not less than 2/3 of the members in good standing. In the event of the dissolution of the Club, other than for the purpose of reorganization, whether voluntary or involuntary or by operation of law, none of the property of the Club nor any proceeds thereof nor any assets of the Club shall be distributed to any members of the Club, but after payment of the debts of the Club its property and assets shall be given to a charitable organization for the benefit of Corvairs, selected by the Board of Directors.*”

These proposed changes will be posted in the upcoming Driplines for review with a vote planned no earlier than May.

Corvair Preservation Foundation Museum Receives New Recognition



THOSE OF YOU WHO HAVE MADE the trek on Route 66 in recent years may have noticed or stopped by a facility dedicated to Chevrolet's famous air-cooled car. General Motors has now officially recognized the Corvair Preservation Foundation Museum in Glenarm, Illinois, as the official Corvair museum in North America. The museum,

in operation since 2016, hosts events throughout the year to celebrate and preserve the legacy of the popular compact car.

"It is with great joy and genuine excitement that we announce the official new name of our 'National Corvair Museum,' which has just been approved by General Motors," Mike Hall, CPF President and Museum Curator, says. "We look forward to a long and productive partnership with General Motors as Corvair will now have a national home for its display of historical vehicles, engines, and artifacts, as well as an archive for the history of this air-cooled wonder."

As it stands now, the museum hosts a variety of Corvair cars, trucks, vans, customs, powertrain displays, and other memorabilia. It has also been added to the Route 66 Historic Traveler's Tour Guide. For more about this facility, visit corvairmuseum.com.

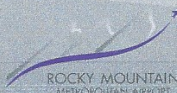
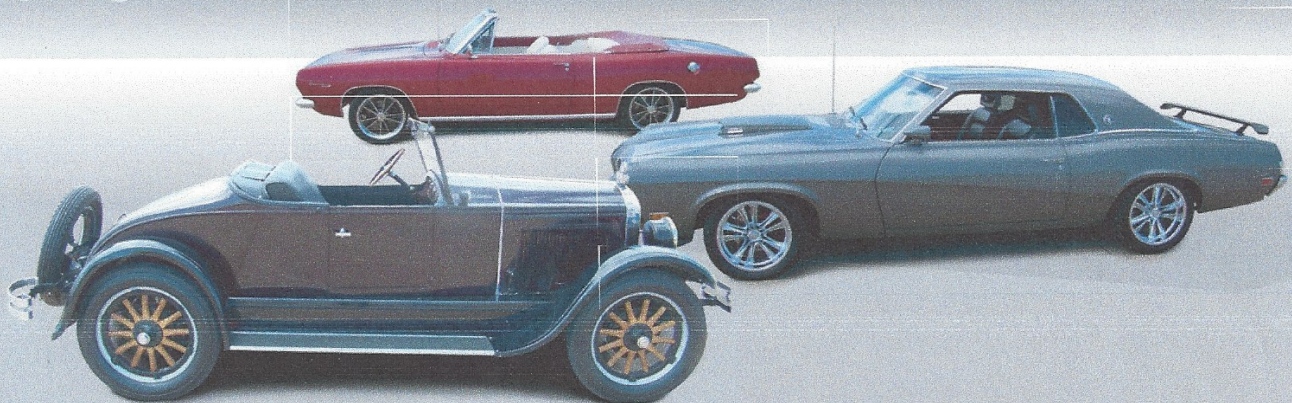
